

# Privacy Policy

## 1. Introduction

SURE ALGO LLC ("SURE ALGO") takes the privacy of its users seriously. This Privacy Policy describes how SURE ALGO collects, uses, and discloses personal information from users of its websites and services ("Services").

## 2. Information We Collect

SURE ALGO collects personal information in various ways when you interact with the Services, including:

- SURE ALGO treats any personal information contained in cookies with the same confidentiality as other information you provide. You can disable cookies by changing your browser settings, but some portions of the Services may not function properly without them.

#### **4. Information from Third-Party Sources**

SURE ALGO may obtain information from third-party sources, including social media services, with your authorization. This information may include your name, email address, current city, profile picture URL, and other personal information made available by the third-party service.

#### **5. Use of Your Personal Information**

SURE ALGO uses your personal information for various purposes, including:

- Necessary to perform a contract with you (e.g., provide Services)

- Processing is in SURE ALGO's legitimate interests and not overridden by your data protection interests or rights
- You have provided consent
- There is a legal obligation to collect the information

## **8. Your Rights**

You have certain rights regarding your data under applicable law, including:

- Right to have inaccurate data corrected
- Right to have your data erased under certain circumstances
- Right to restrict use of your data
- Right to data portability
- Right to object to processing of your data
